Judging is to be conducted exclusively according to the FCI breed standards (except for breeds non-FCI breeds). The show organizer agrees to follow all the FCI rules regarding the organization of a dog show, the maximum amount of dogs to be judged per day, the judge's accommodation and travelling arrangements as written in the International FCI Regulations.
